Season's Greetings, and Merry Christmas from the Creels! We hope that you and your family are doing well and enjoying this festive season. Even in this most unusual year, we have much for which to be grateful. At the top of our “gratitude list” is the gift of God’s Son, Jesus Christ, who gave of Himself so that we might enjoy abundant life here on earth and eternal life someday with Him in heaven. We are also grateful for your partnership as we proclaim “Christ to the World by Media” until all have heard the story of Jesus. With your help, FEBC has proclaimed Christ to the unreached for the past 75 years. That work continues even in the midst of the Coronavirus pandemic.

Some highlights from the past year include:

- Kyrgyzstan – the establishment of a 6<sup>th</sup> radio station in the city of Osh enabling over a million souls to hear the Gospel.
- South Korea – the upgrading of HLKX-AM which will allow millions in Korea to hear the Good News.
- Cambodia – the upgrading of the Kampong Thom relay station allowing over a quarter of a million people to hear about Jesus Christ.
- Radio Distribution – Over 8,500 radios have been distributed to listeners in 2020, many of whom have no other way to hear the Gospel.
- Listener Response – FEBC has seen a tremendous increase in response from listeners during the pandemic.



Since our previous update, David has been busy with projects in Mongolia, Cambodia, and India. In Mongolia, WIND-FM in the capital city of Ulaanbaatar needs some new audio equipment, so David has been assisting by getting quotes and placing orders. In Cambodia, Family FM in Phnom Penh is considering replacing their guyed tower with a self-supporting tower to free

up some space at their transmitter site. So, David has been conducting FM coverage studies to evaluate the impact on coverage when towers of various heights are used. In India, a new community FM radio station is being planned, so David has been compiling a list of recommended equipment.
